



# CHINA CUSTOMS ADVANCE MANIFEST (CCAM)

## APPLICABLE TO INBOUND CARGO ENTERING CHINA (DIRECT CALLS + TRANSHIPMENT CARGO)

In order to comply with the Adjustment to China Customs Advanced Manifest (CCAM) hereunder are some of the new requirements according to GACC announcement No. 56 – 2017.

Please make sure you provide all details stated below in your SI to avoid unnecessary delays when issuing your BL draft and avoiding possible issues when filing your booking to Customs.

### SHIPPER

- Full **name** (no abbreviations are allowed)
- Full **address** (street, postal code, country)
- Company code (**NIF**). When physical person, TAX ID must be accompanied by photocopy of the same
- **Contact person** name
- **Phone** number
- **Email** address

### CONSIGNEE

- Full **name** (no abbreviations are allowed) \*
- Full **address** (street, postal code, country) \*
- **Identifier + company code** (USCI or OC) \*
- **Contact person** name \*
- **Phone** number \*
- **Email** address

\* **Mandatory if CEE is not "TO ORDER"**

### NOTIFY

- Full **name** (no abbreviations are allowed)
- Full **address** (street, postal code, country)
- **Identifier + company code** (USCI or OC) \*
- **Contact person** name
- **Phone** number \*
- **Email** address.

\* **Mandatory if CEE is "TO ORDER"**

○ Shipper's company code is shipper's company TAX ID (NIF).

○ Company code for consignee located in China is USCI + number (contains 18 digits or numbers). In case there is no USCI, then OC + number must be provided.

USCI = Unified Social Credit Identifier.

OC = Organizing institution bar Code.

○ If shipper or consignee are a physical person, then code must be ID number or passport number.

## CARGO DESCRIPTION

Description of goods must be clear and precise, and must match HS code provided.

Hereunder a few of examples provided by China Customs regarding non-acceptable and acceptable descriptions:
