Shipping Instruction – Complete Information:

In order to ensure smooth documents and cargo clearance, we requires the details of all products are declared with correct & complete information. We always recommend for electronic submission of Shipping Instruction via our Website, for manual submission we required Shipping Instruction in a copy paste format. The following are the mandatory information that should be available in Shipping Instruction:

1. Booking Number
2. Shipper
3. Consignee
4. Port of Loading/Receipt
5. Port of Delivery
6. Container number and Seal number
7. Number of packages
8. Cargo Description
9. Gross Weight, Volume and Tare Weight for SOC Container (breakdown per container)
10. Term of payment (prepaid or collect)
11. Bill type : Negotiable Bill of Lading or Waybill
12. Split or combine BL (Ensure to send split or combined in batch)

1. BL amendment and Draft approval/BL OK
Once you received BL draft and all in order, please acknowledge via Website that the BL is OK.
For any BL amendment, please submit via online or email to ssc.sgexportdocs@cma-cgm.com
For any first amendment after 1st BL draft has been published will be subject to SGD 75 (manual) & SGD 60 (eSI).
If no confirmation within 48 hours after draft BL sent, BL will be issued.
Any BL re-issuance queries will be subject to BL re-issuance fee of SGD 190.
For any resubmission for ENS/AMS/ACI fee will be subject to USD 50 per BL.
Fore any resubmission for AFR & CCAM will be subject to USD 40 and resubmission of AMANAC will be subject to USD 30.
2. Shipped on board Date
Shipped on Board Date showing on the draft BL is Vessel ETD Date.
After vessel departure Shipped on board date might change as per Actual Departure Date.
Correct SOB date will appear on the BL at the time of BL Release.

- 8) Stuffing and Unstuffing on Shipper/Consignee own cost.
- 9) Subject to THC and Carrier local charges publish in Agency Tariff Book
- 10) Additional Charges apply for standby/waiting time, additional truck moves, direct loading/discharges ...
- 11) Excludes Customs duties, Custom Bond, GST, and other charges payable to Government & Authority.
