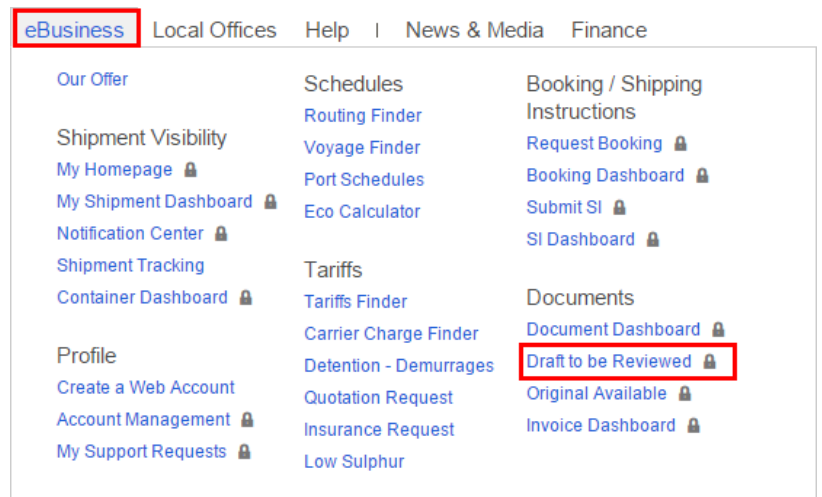

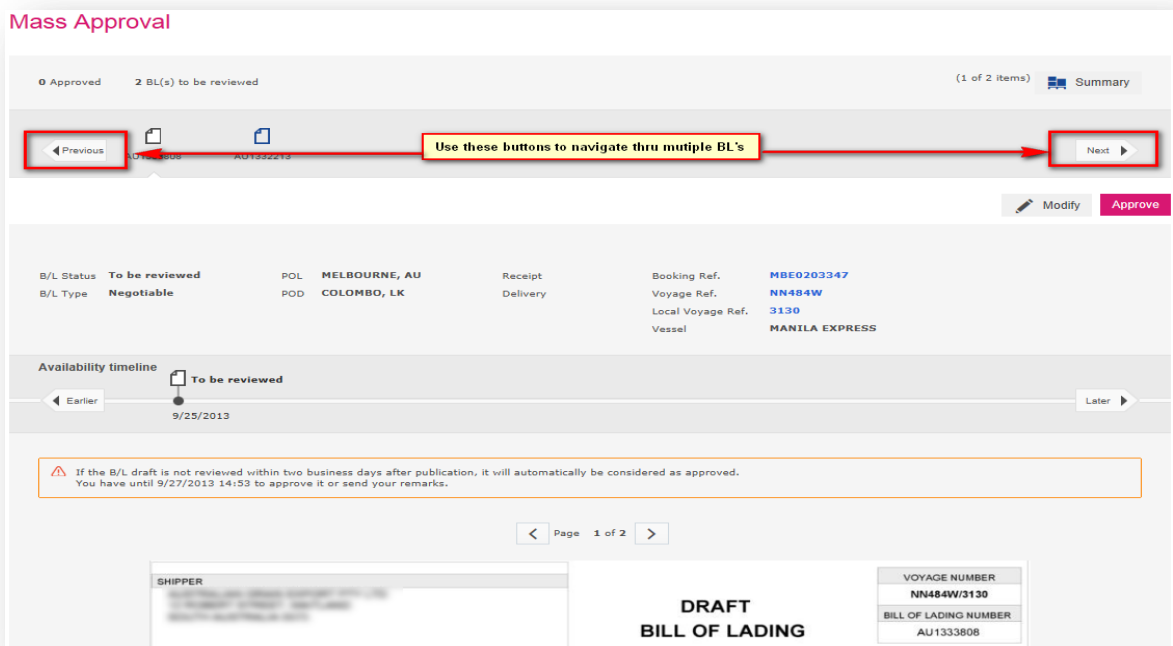
Mass Approval/Quick Approval:
