CMA CGM offers you the possibility to access your Bills of Lading online. Available 24/7 through a secure access on our website, you can access, download and print your BLs anywhere, simply at the click of a button. As soon as they are edited by your local CMA CGM Agency, they are posted to your account in which you can choose to be notified by email or through your online notifications.











ACCESSING DOCUMENT DASHBOARD

CMA CGM eBusiness platform offers customisable dashboard to manage & access the documents published online. You can Filter or Sort list of documents or even can export data in Excel or PDF format.
